Hostage/Crisis Incident First Responder

“Verbal Containment”

From the onset, throughout the first hour always proves to be the most chaotic and potentially dangerous timeframe involving any hostage, crisis or barricade situation. Emotions create a volatile situation and the risk of death or serious injury to all persons involved is extremely high. Although many police departments’ have no clear protocol in place, or either advocate procedures that advise delaying contact until the arrival of SWAT or Negotiators, the FBI advocates making prompt contact into the crisis site in order to achieve “Verbal Containment.”

“Verbal Containment” is defined as quickly beginning some form of communication into a crisis site, or with a hostage taker or barricaded individual, in order to prevent them from committing other acts of violence, harming hostages, formulating plans to attack the police, fortifying the crisis site and to begin the portraying of a calm and professional police presence.

The 8 hour First Responder Course (SCCJA Course Number E4137) outlines the critical need for immediate contact into the crisis site and teaches **all levels of First Responders from Dispatch Personnel to First Line Supervisors**, the skills needed to maintain a sense of order prior to the arrival of Negotiators and SWAT.

Instruction Points include:

- Incident and Threat Assessment
- Understanding Hostage/Non Hostage
- Definition of “Crisis”
- Active Listening Skills
- Dealing with Deadlines/Demands
- Suicidal Ideology and “Suicide by Cop” concerns
- Intelligence Gathering
- Actual Case Study of a Hostage Taking

Presenter Biography

Lieutenant Scottie Frier currently serves as the Deputy Commander of the Investigations Unit within the Lexington County Sheriff's Department in South Carolina. This unit consists of Major Violent Crimes Detectives, Law Enforcement Victims' Advocates, CSI Detectives, AFIS Fingerprint Technicians and the Forensic Drug Lab. Lieutenant Frier began his law enforcement career with the City of Clemson Police Department in 1985 before being hired with Lexington County in 1987.

Lieutenant Frier also serves as the Deputy Commander and Training Coordinator for the Lexington County Crisis Negotiations Unit. This unit consists of two teams of officers specifically trained in the area of non-violent crisis resolutions. Lieutenant Frier has been a member of this unit since 1997 after completion of the South Carolina Department of Corrections Situation Control Training Class, and has conducted multiple law enforcement crisis negotiations.

In January of 2008, Lieutenant Frier attended the FBI National Crisis Negotiators Course held in Quantico, Virginia as a domestic law enforcement representative.

Lieutenant Frier is a certified instructor through the South Carolina Criminal Justice Academy, and has provided several areas of instruction relating to crisis negotiations for law enforcement negotiators, first responders, patrol officers, State Crisis Negotiations Associations, and communications personnel. Lieutenant Frier has also authored lesson plans certified through the South Carolina Academy.

Lieutenant Frier has also had an article published in a national law enforcement magazine regarding a piece written on First Responder to Crisis Negotiations. (Law Officer Magazine, September 2007, Volume 3 Issue 9 Pg. 44)
