**Registrations accepted the morning of the tournament prior to blast off.**

1. Weighed in fish must be largemouth bass caught in Lake Murray during the tournament hours by use of artificial bait on a line and pole.
2. 14" minimum length per fish.
3. Limit of **5** fish per team.
4. No fishing within 100 yards of another anchored participant.
5. Entrants are required to abide by all state and federal wildlife and boating laws and regulations.
6. Entrants are required to wear approved flotation devices while under power of gasoline engine.
7. Fish should be alive when weighed in (2 oz penalty will deducted for **EACH** dead fish).
8. Each big fish entry will be marked or singled out by participant before weighing in.
9. Winners are subject to polygraph test to verify compliance.
10. Violation of any of the rules by either partner will disqualify the team from eligibility for prizes.
